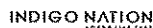
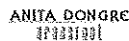

### Investment in Indus-League Clothing Limited (“ILCL”)

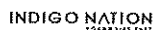
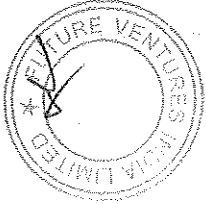

The total income of ILCL for the financial year ended 31<sup>st</sup> March, 2012 is ₹ 369.53 Crore with Profit After Tax of ₹ 3.75 Crore during the previous year.
